- The *approximate* cost of the Band Tour is \$2,665. This total includes all transportation, lodging, 5 breakfasts, 4 dinners, and the cost of all planned events. The total tour cost will likely go down, and the *estimated* final cost will be closer to \$2,400. Costs will further come down through fundraising.
- The above-named participant intends on participating in the 2023 New York Tour.
- I agree to accept responsibility for the remaining balance of the trip cost per the attached payment schedule.
- If for any reason the above named participant cancels their participation on this trip, I understand that the initial deposit is non-refundable.
- Participants may be removed from the trip for failure to comply with the attached payment schedule. You will be notified verbally and by e-mail and then given two weeks to submit the delinquent funds.
- Payment of the installments must be made in a timely manner through either SchoolPay.com or a personal check/money order made payable to WPHS Band.
- If a financial situation arises and a payment cannot be made on time, I agree to notify Mr. Clemente via e-mail at Michael.Clemente@ocps.net before the payment deadline.
- All incidental costs (souvenirs, lunches, meals to and from New York City) associated with the tour are the sole responsibility of the participant and his/her Guardian.
- Mr. Clemente and/or the WPHS Administration may deny participation in this event based on disciplinary actions.
- All Band fees and obligations must remain current in order to participate in this tour.

NEW YORK TOUR PAYMENT SCHEDULE

The schedule below is subject to change due to estimated costs, as well as fundraising. Updates will be sent out prior to each payment due date by Mr. Clemente.
